FILING REQUIREMENTS

The Articles of Revival must be filed with the applicable fees and an original of the following:

- Annual Returns not previously filed,
- Notice of Address/Change of Address (Form SA0091),
- Notice of Directors/Change of Directors/Change of Director's Address (Form SA0088),
- if the cooperative's articles have changed, a Summary of Articles of Incorporation (Form SA0089) must be submitted,
- declaration required under Section 329(2) of the Cooperatives Act (Form SA0097A), and
- if the cooperative has been dissolved for more than three years, the articles must be submitted with an Alberta Name Search Report (from the NUANS database), dated not more than 90 days prior to the date the Articles of Revival are received by the Alberta Government .
